



# LARAMIE JUBILEE DAYS® KIDS' HORSE SHOW RELEASE AND WAIVER OF LIABILITY

***By signing agreement as you are giving up certain rights, including the right to recover damages in case of injury, death, or property damage. Read carefully before signing.***

I, the undersigned participant or the parent/legal guardian of the participant if the participant is a minor, hereby acknowledge, consent, warrant, and covenant that:

1. In consideration for allowing the participant to freely and voluntarily enter, compete, and participate in the Laramie Jubilee Days® Kids' Horse Show event (herein "the Event"), I hereby irrevocably and forever release, discharge, and hold harmless Laramie Jubilee Days, Inc., a Wyoming non-profit corporation ("LJD"), its officers, directors, committee members, volunteers, agents, contractors, guests, sponsors, invitees, successors, and assigns, as well as Albany County and the Albany County Fair Board, its members and agents, and all other persons or participants who may have an association with the Event and activities associated therewith, from any and all legal claims or legal liability of any kind, nature, and description, including but not limited to losses, expenses, property damage, or injuries suffered or sustained, foreseen and unforeseen, which may arise in connection with or as a result of participation in the Event and whether such injury results from the negligence of LJD or any of its officers, directors, contractors, agents, participants, and volunteers, or from any other cause.

2. I am either the participant or the parent or legal guardian responsible for the participant if the participant is a minor and I have the legal authority and capacity to enter into this agreement for myself and on behalf of the participant.

3. I understand livestock may, and without warning or apparent cause, buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's feet, push or shove a person, etc., and that steel panels, saddles, bridles, and other equipment may loosen or break all of which may cause the rider to fall, be jolted, or otherwise placed at risk, resulting in serious injury to themselves; as such, I acknowledge that the Event is an inherently dangerous activity and that participation could result in property damage, serious injury, or even death.

4. I understand and accept, for myself and on behalf of the participant, all the risks and hazards that may result from participation in the Event and I knowingly, voluntarily, and freely assume all risks of the participant, myself, and our heirs, successors, and assigns in connection with the Event of any harm, injury, or damage to any person or property, whether foreseeable or unforeseeable, that may occur as a result of participation in the Event.

5. I promise not to sue LJD or any of its officers, directors, and agents and agree to indemnify and hold harmless each of them from any liability asserted by any person or entity on account of any injury to the participant, including death, and I further waive any and all claims, demands, actions or causes of actions against them or each of them arising out of or related in any way to the Event or any participation in the Event, whether said claim, demand, or cause of action arises from the negligence of LJD or any of its officers, directors, contractors, agents, participants, volunteers, or from any other cause.

6. I acknowledge Wyoming's Recreation Safety Act (Wyo. Stat. Ann. § 1-1-121 et seq.), and understand that according to this state law, individuals assume the inherent risk of recreational activities. I understand that under Wyoming law, LJD is not required to eliminate, alter or control the inherent risks within the particular sport or recreational opportunity and that LJD makes no warranty as to the fitness, suitability, or safety of any property, machinery, activities, facilities, equipment, animals, vehicles, services or property it provides to me, if any.

7. I understand this document is not meant to waive any immunity, protection, defense, claim, contention or position available to LJD under state or federal law or common law. I verify and confirm I have sufficient health, accident, and liability insurance to cover any property damage or bodily injury or death caused by me, the participant, LJD, or a third party and that if I have no such insurance, I certify that I am responsible for any and all expense or liability.

8. I am aware that the risk of injury from participating in the Event is significant, including the potential for permanent paralysis and death. These are hazardous activities, involving inherent and other risks of injury to any and all parts of the body and death. I understand that injuries resulting from the Event are a common and ordinary occurrence and I freely accept and assume those risks. I knowingly, voluntarily, and freely assume all such risks that may result from participating in the Event and that may relate in any other way to LJD, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF LJD, its directors, agents, volunteers, representatives, officers, or others, and assume full responsibility for my decision to participate in the Event.

9. This agreement is meant to apply to past, present, or future claims, without regard to when I or the participant participate in the Event, whether before, concurrent with, or after my signing of this document. This release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the State of Wyoming, and that if any portion thereof is held invalid, the remaining provisions shall, notwithstanding, continue in full legal force and effect. This release of liability shall be binding on me, the participant, and our families, estates, heirs, executors, administrators, personal representatives, successors, and assigns and shall inure to the benefit of LJD and all its officers, directors, volunteers, and agents, and their heirs, executors, administrators, personal representatives, assigns, and successors in office.

10. I agree that photographs, pictures, or videos may be taken of me or the participant in connection with the Event without compensation from anyone, and I consent to LJD's use of these photographs, pictures, or videos for any legal purpose.

**BY SIGNING THIS DOCUMENT, I CONFIRM THAT I HAVE CAREFULLY READ THE FOREGOING RELEASE, THAT I UNDERSTAND THE CONTENTS THEREOF, AND AGREE TO THE TERMS OF THIS RELEASE AS MY OWN, FREE AND VOLUNTARY ACT. I ASSUME AND ACCEPT FULL RESPONSIBILITY FOR THOSE RISKS IDENTIFIED HEREIN AND THOSE RISKS NOT SPECIFICALLY IDENTIFIED, AND FOR INJURY, DEATH, ILLNESS, PROPERTY LOSS AND EXPENSES RESULTING FROM THOSE RISKS, AND FROM MY OWN NEGLIGENCE IN PARTICIPATING IN THE EVENT. I UNDERSTAND THAT I MAKE CERTAIN PROMISES AND WAIVE CERTAIN SUBSTANTIAL RIGHTS, INCLUDING THE RIGHT TO SUE.**
